

INSTRUCTIONS FOR KIT #2008390 SINGLE EXHAUST KIT

Kit fits '87-'90 full-size GM ½ ton Suburban, 2WD, w/350 c.i. motor only and 3" exhaust at the converter.

**NOTE:** DO NOT TIGHTEN ANY CLAMPS OR BOLTS UNTIL THE LAST STEP!

- 1) REMOVE THE EXHAUST SYSTEM AT THE CLAMP BEHIND THE CONVERTER LEAVING ONLY THE ORIGINAL Y PIPE, RUBBER MOUNTS, AND CATALYTIC CONVERTER ON THE TRUCK.
- 2) SLIP THE FRONT EXTENSION PIPE (IT HAS TWO BENDS) INTO PLACE ON THE CONVERTER AND SLIDE A 3" CLAMP ON THE PIPE.
- 3) ATTACH THE HANGER ON VEHICLE TO THE FRONT EXTENSION PIPE USING A 3" CLAMP.
- 4) USE A 3" MUFFLER CLAMP TO ATTACH THE INLET OF THE MUFFLER AND THE FRONT EXTENSION PIPE TOGETHER.
- 5) INSTALL THE OVER THE AXLE SECTION OF THE TAIL PIPE USING A 3" CLAMP TO THE OUTLET OF THE MUFFLER.
- 6) INSTALL THE REAR SECTION OF THE TAIL PIPE USING A 3" CLAMP.
- 7) USE A 3" CLAMP TO CONNECT THE REAR PORTION TAIL PIPE TO THE O.E. HANGER.
- 8) TIGHTEN ALL CLAMPS AND CHECK FOR CLEARANCE OF ALL BRAKE AND FUEL LINES, AND FRAME AND CHASSIS CLEARANCE.


