

INSTRUCTIONS FOR KIT #2008400 SINGLE EXHAUST KIT

Kit fits '94-'95 full-size GM 1/2 & 3/4 ton Suburban, 2WD & 4WD, w/350 c.i. motor only and 2-3/4" flanged exhaust at the converter. www.heartthrobexhaust.com 320-693-0222

NOTE: DO NOT TIGHTEN ANY CLAMPS OR BOLTS UNTIL THE LAST STEP!

- 1) REMOVE THE EXHAUST SYSTEM AT THE FLANGE BEHIND THE CONVERTER LEAVING ONLY THE ORIGINAL Y PIPE, RUBBER MOUNTS, AND CATALYTIC CONVERTER ON THE TRUCK. YOU WILL NEED TO REUSE THE ORIGINAL NUTS AT THE FLANGE AFTER THE CONVERTER.
- 2) SLIP THE FRONT EXTENSION PIPE (IT HAS FOUR BENDS AND A WELDED FLANGE) INTO PLACE ON THE CONVERTER FLANGE AND ATTACH USING THE ORIGINAL NUTS.
- 3) ATTACH THE HANGER ON THE FRONT EXTENSION PIPE TO THE O.E. HANGER ALONG SIDE THE PIPE.
- 4) USE A 3" MUFFLER CLAMP TO ATTACH THE INLET OF THE MUFFLER AND THE FRONT EXTENSION PIPE TOGETHER, ROTATE THE MUFFLER FOR CLEARANCE OF THE DRIVESHAFT AND FRAME.
- 5) INSTALL THE OVER THE AXLE SECTION OF THE TAIL PIPE USING A 3" CLAMP TO THE OUTLET OF THE MUFFLER.
- 6) INSTALL THE FRONT HANGER CLAMP (IT HAS THE LONGER WIRE HANGER ON IT) TO THE OVER THE AXLE SECTION OF THE TAIL PIPE, AND CONNECT THE WIRE PORTION OF THE HANGER TO THE O.E. RUBBER HANGER MOUNT ABOVE.
- 7) INSTALL THE REAR SECTION OF THE TAIL PIPE USING THE REAR HANGER CLAMP, CONNECT THE WIRE PORTION OF THE HANGER TO THE O.E. RUBBER HANGER MOUNT ABOVE.
- 8) TIGHTEN ALL CLAMPS AND CHECK FOR CLEARANCE OF ALL BRAKE AND FUEL LINES, AND FRAME AND CHASSIS CLEARANCE.

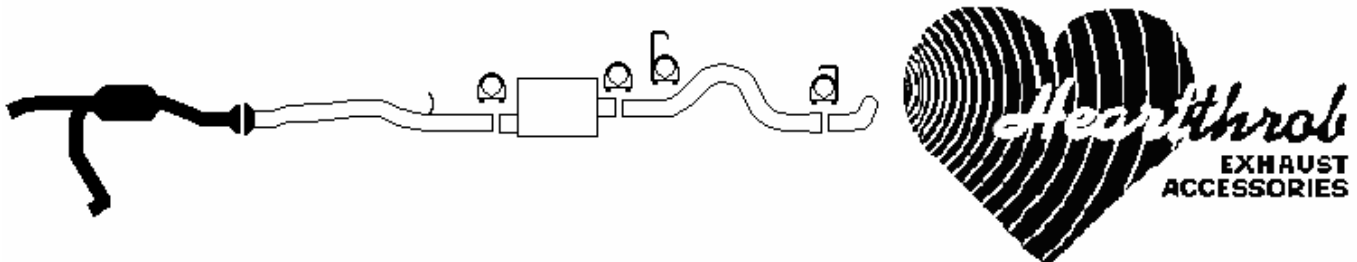
